The company undertakes to act in an ecologically responsible manner in the interest of its employees, customers, suppliers and in the area surrounding the production site. ESIM is committed to constantly improving processes and operational environment protection beyond compliance with all relevant legal regulations. Energy efficiency is an important evaluation criterion for procurement processes.

ESIM's environmental management system is regularly reviewed by customers, authorities and suppliers through internal and external audits (ISO 9001, ISO 14001, ISO 45001, ISO 50001).

As an employer, ESIM guarantees fair working conditions and is committed to treating all employees, business partners and applicants honestly and with respect. To ensure responsible corporate governance, ESIM has implemented processes and guidelines in amongst others the following areas: protection of personal data, IT-security, anti-corruption, conflicts of interest and anti-competitive practices. Our compliance system ensures, that applicable laws and guidelines are continuously complied with.

In addition, a risk management process was created as part of the integrated management system at ESIM. This process regulates the handling of risks as well as the structure and process of risk management in the company. This process ensures that a uniform and systematic method for identifying, assessing, controlling, managing and communicating risks is used throughout the organization and that the risk management system is monitored and updated continuously.
